Official Rules

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCE OF WINNING. OPEN ONLY TO LEGAL RESIDENTS OF THE UNITED STATES WHO RESIDE IN PA, NJ AND DE, AND ARE 18 YEARS OF AGE OR OLDER AS OF DATE OF ENTRY. VOID OUTSIDE PA, NJ AND DE AND WHERE PROHIBITED.

1. ELIGIBILITY: The Flyers Playoff Tickets Sweepstakes (the “Sweepstakes”) is only open to entrants who are legal residents of the United States residing in Pennsylvania, New Jersey or Delaware, and who are 18 years of age or older as of the date of entry. The following persons are not eligible to enter the Sweepstakes or win the Prize (as defined below): employees of Philadelphia Flyers, L.P. (“Sponsor”) the National Hockey League and its member teams, and NHL Enterprises, L.P. and their respective parents, affiliates, subsidiaries and advertising and promotion agencies and Prize Providers (as defined below), and the immediate families (spouse, parents, siblings and children and their respective spouses, regardless of where they reside) and members of the households, whether or not related, of each of the above. The Sweepstakes is subject to all applicable federal, state and local laws. HOW TO ENTER: The Sweepstakes will start on April 28, 2026 upon posting of the Official Rules at <https://go.comcastspectacor.com/FlyersTicketSweepstakes429> and end on April 29, 2026 at 11:59:59 a.m. Eastern Time (“ET”) (the “Entry Period”). To enter the Sweepstakes, follow the directions provided to complete the online entry form at <https://go.comcastspectacor.com/FlyersTicketSweepstakes429> and submit electronically during the Entry Period. LIMIT ONE (1) ENTRY, PER PERSON. Sponsor’s computer will be the official timekeeper for all matters related to this Sweepstakes. The use of automated devices to enter this Sweepstakes is prohibited. Entries generated by script, macro or other automated or mechanical means and entries generated by any other means which subvert the entry process will be void. Any attempt by any person to obtain more than the stated number of entries will void all of that person’s entries and that person will be disqualified. Each entrant must fully complete and submit all non-optional data requested on the entry form to be eligible. Incomplete and/or inaccurate entries are void. No entries will be acknowledged or returned. Proof of submission will not be deemed to be proof of receipt by Sponsor.

Sponsor shall have no responsibility or liability for cancellations, delays, or any other change by any company or person providing any element of the Prize(s) (each a "Prize Provider") due to reasons beyond Sponsor's control, and is not responsible or liable for any expenses incurred as a consequence thereof. The date and/or time of event are subject to change. The event is subject to cancellation. Tickets are subject to certain terms and conditions as specified thereon and by applicable issuer. The Prize(s) are not transferable, and no substitutions or cash redemptions are allowed, except by Sponsor, which reserves the right to substitute the Prize (or any component thereof) with one of comparable or greater retail value, at its sole discretion.
