Official Rules

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR WIN. VOID OUTSIDE PA, NJ AND DE AND WHERE PROHIBITED.

1. **ELIGIBILITY:** The Wingston Bundle Sweepstakes (the “Sweepstakes”) is open only to entrants who are legal residents of Pennsylvania, New Jersey or Delaware, 18 years of age or older as of the date of entry. The following persons are not eligible to enter or win: employees of CS Philadelphia Lacrosse Team, LLC, the National Lacrosse League and its member teams and each of their respective parents, affiliates, subsidiaries, and advertising and promotion agencies and Prize Providers (as defined below), and the immediate families (spouse, parents, siblings and children, and their respective spouses, regardless of where they reside) and members of the households, whether or not related, of each of the above.
